

POLICING BY CONSENT

The power of the police to fulfil their functions and duties is dependent on public approval of their existence, actions, behaviours and on their ability to secure and maintain public respect.

***The police are the public and the public are the police.
Police are members of the public who are paid to give full time attention to duties which are incumbent on every citizen in the interests of community welfare and existence.***

The blatant and deliberate failures of our police to investigate, arrest and prosecute named offenders for committing multiple serious and on going crimes, now makes it our duty as unpaid citizens to give these matters our full and immediate attention.

You have lost our respect, you have failed to carry out your paid duty in favour of suppressing, hiding and ignoring vast, irrefutable and damning evidence of serious crimes. Crimes relating to the pandemic. Every man, woman and child is a victim of these most heinous crimes at the hands of those we pay and employ to take care of us and keep us safe. The vaccine harms and deaths are many and catastrophic and you are acting unlawfully by allowing them to continue to be administered.

The blatant disregard for the rape gang victims is an indelible stain on the police service.

The complicity in allowing our borders to be breached by a criminal invasion of unvetted men, some of whom rape and murder our people.

They are afforded unlimited police protection 24/7 at the expense of our own.

We will now assert our basic right in law, to defend ourselves, our families and our property. To defend and protect each and every one of us from harm, injury, loss and damage.

The police have adopted an unfair, bias and divisive two tier undemocratic policing style.

Politicians, civil servants and police constables are afforded special treatments, leniency and no punishment or accountability.

Yet, the public are arrested, heavily fined or imprisoned and criminalised for minor and low level indiscretions.

You no longer police without fear or favour, you no longer police with impartiality, you no longer police without interference or independence from government, you no longer work for the people, by the people of the people. You protect the criminals as well as named and known offenders.

You have broken your oath of appointment as constables, broken our trust and confidence in you, to such a degree, to remove the consent we give for you to police.

Our law is your law, your law is our law. No man or woman, no matter title or financial status, no corporation public or private are above the law. We are all equal in the eyes of the law. It is abundantly clear, you, our police have forgotten this.

Where the British police have wilfully failed, the British people are duty bound to act. We must protect each other from harm, injury, loss and damage. To arrest those who are guilty of these serious crimes and use force as is reasonable, necessary and proportionate. This is written in law and applies to all men and women and to the police also. You are not above the law despite what you might think.

We have begged you, our police, to stop the harms being caused and arrest those responsible. We have written, emailed, called, visited, protested and pleaded with you for years and you've treated us with utter contempt, ridicule and dismissed us as conspiracy theorists, tin foil hat wearing anti vaxxers, far right and racist thugs.

What we are is caring, loving, law abiding men and women trying to protect our children, the elderly, every man, woman and child and protect our country from serious harms, nothing more nothing less.

Your multiple failure's as our publicly-paid police constables now leaves us with the unenviable task of having to remove consent for you to police as is our fundamental constitutional right.

We all have a public duty to protect each other from harm, to make absolutely sure there is accountability with the appropriate punishment for the guilty and most importantly, remedy and redress for the many victims of these serious crimes. Policing is supposed to be victim-led: you have failed on all counts despite the vast amount of damning and irrefutable evidence supplied to you proving the criminality being committed by the Government, members of Parliament, civil servants, media bosses, rape gangs, migrants entering illegally and many police Constables especially in senior positions.

CONSENT IS REMOVED.

Consent will only be returned when and if you agree to carry out your lawful duties. Those responsible for committing the most serious crimes against the people of this country must be arrested immediately.

We will remain lawful, stand in our honour, maintain order and keep the peace.

We will negotiate but we will not acquiesce.
