

# Volcanic Condemnation: The Regulators, the Police, and the Great Silence

## **Introduction: A Nation Betrayed**

Britain and Ireland stand at a constitutional breaking point. The institutions charged with protecting life and upholding justice, the regulators and the police, have abandoned their duties.

- Regulators have become inquisitors, hunting down doctors, lawyers and professionals for daring to question the COVID-19 vaccine programme or the policies surrounding it.
- Police have become guardians of silence, refusing to hear evidence of harm, deflecting citizens into dead ends and suppressing criminal allegations without investigation.

This is not error. It is design. Together, regulators and police have created a system of organised suppression, where truth is punished and accountability erased.

## **Regulators as Enforcers of the Lie**

Across the UK, Ireland, and beyond, regulators have been weaponised against their own members.

### - Doctors:

- Dr David Cartland erased from practice despite zero patient complaints.

- Dr Marcus de Brun prosecuted in Dublin for tweets and speeches after resigning in protest at nursing home deaths and denied therapeutics.

- Dr Aseem Malhotra persecuted by vexatious complaints for raising vaccine safety issues.

- Dr William Bay (Australia) suspended, only to be vindicated by the Supreme Court, which ruled the regulators' actions "profoundly unsatisfactory."

### - Other professions:

- Physiotherapists targeted by the HCPC for social media posts.

- Solicitors hounded by the SRA for representing clients challenging mandates.

- Nurses, pharmacists, teachers and academics punished for questioning government policy.

Not one of these cases involves patient harm. All involve

speech. Regulators are not protecting patients. They are protecting policy.

### **Police as Guardians of Impunity**

While regulators crush professionals, the police ensure the public remains voiceless.

- England and Wales: CRN 6029679/21, containing hundreds of expert reports and witness statements, was closed without admitted investigation, which has now been proven, did occur.
- Scotland: Police Scotland enforced the “Speirs Directive,” instructing officers to reject vaccine-related complaints on orders from the NPCC and UK Gold Command.
- Northern Ireland: The PSNI refused to investigate vaccine deaths and adverse reactions even when presented with official MHRA evidence. They cited “national directions” from Operation Talla.

This is not policing. It is a deliberate shielding of state and corporate actors from accountability.

### **Northern Ireland: The Denial of Truth**

The Northern Ireland story exposes the rot with clinical clarity.

- In 2022, the Department of Health NI received official MHRA data showing 48 confirmed vaccine deaths and over 5,000 serious adverse reactions. It withheld this information from clinicians, breaching the law of informed consent.
- When citizens delivered this evidence to PSNI headquarters, police refused to investigate.
- When solicitors invoked Article 2 duties under the European Convention on Human Rights, police still refused.
- Senior officials then gave sworn testimony to the COVID-19 Inquiry denying blanket DNACPR orders and denying use of NG163 guidance - claims flatly contradicted by Assembly records and FOI releases.

These contradictions may amount to perjury and misfeasance in public office. Yet oversight bodies - the Policing Board, the Ombudsman, the Assembly, did nothing.

Northern Ireland stands as proof: when the law threatens the state, the state will abandon the law.

## **Ireland: The Deaths in Nursing Homes**

The Dublin hearings of Dr Marcus de Brun reveal another horror.

- Former IMC President Dr Rita Doyle admitted under oath that hydroxychloroquine, identified by the HSE as beneficial, was withheld from all but hospital patients.
- This policy ensured that nursing home residents, the most vulnerable population, were denied treatment.
- Dr de Brun, who lost patients to this policy, resigned in protest. He tried to raise alarms with the Medical Council and authorities. He was ignored.
- His patients died. His warnings went unheard. And he now faces prosecution for the crime of telling the truth.

The whistleblower is punished. The policy-makers remain untouchable.

## **A Global Pattern**

This suppression is not local; it is global.

- Australia: Dr William Bay restored by the courts, regulators condemned.
- New Zealand: Doctors gagged by intimidation and hardball tactics.
- US and Canada: Doctors suspended and erased,

reputations destroyed for dissent.

- Brandy Vaughan (USA): Former Merck executive, whistleblower, activist - dead at 47 after years of harassment. She warned: *"If anything happens to me, it is not natural."* Authorities called it *"natural causes."*

The pattern is the same: silence dissenters, protect the programme.

### **The Closed Loop of Suppression**

1. Regulators gag professionals, ensuring no authoritative dissent.
2. Police silence the public, ensuring no criminal accountability.
3. Oversight bodies look away, ensuring no correction.

This closed loop is not democracy. It is institutional capture. It is tyranny clothed in law.

### **Conclusion: A Volcanic Condemnation**

The evidence is now beyond dispute.

- Regulators have betrayed their members.
- Police have betrayed the public.
- Oversight bodies have betrayed their duty.

What remains is a system where truth is punished, lies are enforced, and death by policy is excused as “guidance.”
