

WITNESS STATEMENT

My name is Mark Sexton and I am a 57 year old retired police constable from Birmingham formerly of Warwickshire police.

I retired in August 2012, during my time as a constable I dealt with many crimes, victims and offenders. I was considered an outstanding investigator by my peers and as a result I received multiple commendations, plaudits and accolades throughout my career.

I dealt with simple straightforward criminal cases and I also dealt with complex and protracted criminal investigations and enquiries. I gave evidence in Magistrates, Crown and Coroners Courts many times.

I took great pride in being victim focused and always strived to do my utmost in making sure justice was served, there was accountability, but most importantly, remedy and redress for the many victims I dealt with throughout my police career.

In March 2020 a pandemic was declared as a result of COVID-19 and the world changed as we know it. Lockdowns, masks, keeping a distance of six feet apart, the elderly locked in their care homes and so started the greatest and most grotesque fear campaign waged against the people of the U.K in our entire history.

But it didn't stop there, these measures were implemented all over the world and every country seemingly working in lockstep all imposing the same restrictions using the same fear and control strategies against its people.

Two weeks to flatten the curve, to save Grandma and protect the NHS was the mantra used to ensure mass compliance and it clearly worked.

For me none of this made any sense and what I was seeing and hearing twenty four seven across all news channels, in the media, social media, billboards, newspapers, magazines, radio and everywhere we turned was nonstop fear. We were being told this virus was deadly, highly contagious, transmissible and the only way to get back to normal according to Microsoft founder Bill Gates was when everyone takes a Covid 19 vaccine.

I decided to carry out my own independent research to look into these measures and find out a bit more about what was going on not just in the UK but around the world.

It was clear to me something was not right and one of the main catalysts that raised my concerns was the introduction of a PCR test. A test that apparently could tell you if you had the virus even if you had no symptoms, to me this was ridiculous and nonsensical. A virus so deadly you need a test to tell you if you have it.

Another major red flag related to the downgrading of Covid 19 as no longer a High Consequence Infectious Disease (HCID). This was downgraded by the U.K Government on the 19th of March 2020 and the reason given was because of its "Low Mortality Rate".

Yet five days later on the 24th of March 2020 we were all locked down and subjected to a relentless campaign of control and fear. How is this possible but more to the point how was this allowed to happen if Covid 19 had a low mortality rate, but we still need to protect Grandma and save the NHS?

Who was responsible for this, on one hand it's deadly and locked down the world, yet on the other hand it's no longer considered highly infectious because of its low mortality rate? What kind of logic is this?

I took to social media and started to see there were many others raising the alarm asking the same questions. There were some very eminent world experts, scientists, biologists, immunologists, forensic scientists, geneticists, doctors, cardiologists, lawyers, barristers and even a retired High Court judge.

The former Vice President of respiratory illness and vaccination of seventeen years working for Pfizer Dr Michael Yeadon was also very vocal and raising serious concerns about what he was seeing right across the board. If a doctor and expert of his stature and credibility is raising concerns, it really is time for people to sit up and listen.

The more I researched, the more people I spoke to and the more information that was coming out literally by the day it became very clear, criminal acts were being perpetrated against the people of the United Kingdom by its own elected Government.

Despite the warnings from many, the vaccine program took off in earnest and people were being vaccinated as of the 8th of December 2020.

This is where I believe things took a turn for the worst because as we went into 2021, the evidence of serious vaccine harms and many deaths were becoming apparent by the day, yet all ignored by the government, the civil service and the NHS.

The phrase "safe and effective" replaced "save grandma and protect the NHS".

We were being bombarded at every turn, get the vaccine, stop transmission, they are 95% effective and help save Grandma. Children were getting vaccinated to save adults. Absolutely shocking and repugnant at every turn.

Numerous communications were sent to the Prime Minister Boris Johnson and various other government ministers, civil servants and the police demanding the vaccines are stopped due to the significantly high amount of deaths and harms they are causing. These many protestations and warnings fell on deaf ears as "safe and effective" continued to ring out twenty four seven across the nation.

In late May of 2021 a consultant working on the vaccine program from Canada, Dr Byram Bridle raised the alarm stating the Covid 19 vaccines were not staying at the injection site as they were supposed to.

What they were finding is the spike protein was travelling around the body and attacking the main organs and of particular concern was the fact they were settling in and damaging the uterus, ovaries and the female reproductive system. His concerns were ignored, never made public but instead Dr Bridle was investigated for spreading false information. On seeing this devastating evidence for myself and in June of 2021 I made direct contact with vaccine Minister Nadhim Zahawi MP. I provided him with hardcopies of the evidence to his secretary at his constituency office in Stratford-upon-Avon and I also emailed the evidence direct to him at his office in Westminster and Stratford-upon-Avon.

Nadhim Zahawi acknowledged the evidence I submitted but to my absolute horror he ignored the warnings and instead, on that same day he replied to me, he went on national television telling the British public how proud he was of the uptake for the COVID-19 vaccines.

This was a blatant criminal act of Misconduct in Public Office and Misfeasance in Public Office and as such, I reported Nadhim Zahawi for these crimes to officers and Detective Superintendent Peter Hill at Warwickshire police.

As part of my submission of evidence, Dr Michael Yeadon, former vice president of Pfizer, Dr Tess Lawrie the director for evidence based medical research, Clare Wills Harrison a lawyer and a medical doctor called Dr T all provided very detailed evidence based witness statements to fully support and assert the crimes alleged as a result of the harms and deaths the vaccines were causing.

A couple of days later, I was made aware that Nadhim Zahawi MP had made a complaint of harassment against me to Warwickshire police. However, Warwickshire police never accepted his complaint. But what Warwickshire police did do was give Nadhim Zahawi extra patrols around his property for security reasons. Why? I was always polite, courteous, professional and at no point did I ever make any verbal or written threats of any kind. I was reporting crimes that I had identified.

A few weeks later detective superintendent Hill emailed the four expert witnesses and me saying there was no evidence of crime. To me this was very strange because the offences were clearly made out, Dr Michael Yeadon also took great exception to this very bizarre decision and challenged detective superintendent Hill but it fell on deaf ears.

More and more evidence was coming out from all over the world from thousands and thousands of medical experts, data experts, lawyers and even some members of Parliament were starting to question the dangers of the vaccines. Yet the UK government continued with the mantra of "safe and effective" and ignored the vast amount of available evidence to the contrary.

The situation was becoming so desperate and alarming I contacted Sir Graham Brady, the head of the 1922 committee for the Conservative Party and one of Britain's most senior and influential politicians. At my request Sir Graham Brady attended a meeting in Birdcage Walk Westminster on the 21st of September 2021, a meeting I personally organised and chaired.

At the meeting there were fourteen world-renowned experts in medicine, virology, immunology, medical doctors, lawyers, a barrister and a funeral director. For two hours the experts documented the dangers of the harm, injury and death the COVID-19 vaccines were causing. Individually and as a collective they pleaded with Sir Graham Brady that he calls for an immediate cessation of all Covid vaccines in order for a full and transparent investigation to take place in order to protect the public.

Before leaving the meeting Sir Graham Brady requested we as a group put all of the questions that need answering together, send them to him and he will get them answered in parliament. I accompanied Sir Graham Brady back to Parliament and during that two to three minute walk I said to him and I quote;

“If the British public find out government ministers know the COVID-19 vaccines are causing harm, injury and death on a massive scale and did nothing about it, there will be disorder and riots in the streets.”

Sir Graham Brady's reply to me was;

“We thought that would've happened by now.”

Take from that what you will.

For three days solid two of the doctors from the meeting, with assistance from myself, put together sixty seven very important and relevant questions that needed answering in parliament.

Once completed I sent the sixty seven questions to Sir Graham Brady's secretary and she confirmed to me they were sent to him and he acknowledged receipt, and thanked me for organising the meeting.

From that day on I never heard from Sir Graham Brady ever again. This despite multiple attempts by me, all acknowledged by his secretary, he never responded and those questions were never answered in parliament as he requested.

The details of the meeting were leaked to the press and the headlines read that senior Conservative MP Sir Graham Brady met with a number of anti-vaxxers at a location in Westminster. I was named in the press as one of those attending the meeting.

In December 2021, I attended Hammersmith police station in London. I was with lawyer Philip Hyland, lawyer Lois Bayliss, and medical doctor Sam White. Evidence was provided to the police regarding criminal acts surrounding the COVID-19 vaccines, the MHRA, Dame June Raine, The GMC and Charlie Massey were identified and named for the offences of misconduct in public office and corporate manslaughter.

We were issued with a crime number: 6029679/21.

An electronic evidence dropbox was provided for us to provide the detectives at Hammersmith CID with all of the evidence available with regards to these offences.

During Christmas and into the New Year thousands of pieces of evidence were submitted into the dropbox. The evidence consisted of peer reviewed papers, government data (ONS), evidence from the World Health Organisation, statements from victims, witnesses, whistleblowers, and many world experts documenting and detailing the harm, injury and death the Covid 19 vaccines were causing.

News of this criminal investigation and the crime number went viral and as a result I was getting contact from dozens of countries from around the world asking for help. They too were sending evidence directly to the Metropolitan police.

Superintendent Jon Simpson assistant to metropolitan police commissioner Cressida Dick acknowledged a number of the emails that was sent and he in turn forwarded this evidence to the detectives dealing with this investigation at Hammersmith police station.

I received contact from retired and serving police and military, from lawyers, barristers, doctors and members of the public from multiple countries; America, Canada, New Zealand, Australia, Brazil, Argentina, the Czech Republic, Malta, Cyprus, Republic of Ireland, Germany, France and Thailand to name but a few.

I was also contacted via email by Robert Kennedy Junior the nephew of former American President John F Kennedy and son of former Attorney General Robert Kennedy. Robert Kennedy Junior asked me what he could do to help.

Evidence was also being submitted not just by the four original informants, but from around the world and from members of the public all across the United Kingdom.

On the 5th of January 2022 I attended Hammersmith police station and met with detective Nadvornak and detective Au both from Hammersmith CID. I gave them two large folders containing a further one thousand one hundred pages of evidence. They signed to confirm receipt of this evidence. They also stated this criminal investigation is so big, it is too big for the metropolitan police and they will have to request help from outside agencies.

As a result of the already significant amount of evidence being submitted, it became very clear many serious criminal offences had, and continued to be, committed. We identified some of the offenders suspected and believed to be partly responsible for committing these crimes.

The list of named offenders and the further offences were also given to both detectives on the 5th of January 2022:

For the next six weeks evidence continued to pour in from all over the world and the evidence dropbox was still being used to submit thousands of pieces of evidence by the four original informants, of which I was one.

Lawyer Lois Bayliss obtained approximately four hundred statements from victims, witnesses, whistleblowers, doctors, GPs, nurses and care home workers, documenting and detailing evidence of very serious crimes.

I also attended Hammersmith police station on two separate occasions in January of 2022 and hand-delivered the statements to officers working on the case. I have signed documented evidence to show and prove this.

On the 22nd of February 2022 the three original informants and me received a one page letter via email from detective superintendent Tor Garnet from Hammersmith CID stating no evidence of crimes were found and therefore the matter is now closed.

The same day deputy assistant commissioner from the Metropolitan police Jane Connors made a statement to the press claiming no evidence of crime was found and no further investigation is going to take place.

This was a shocking decision, a blatant cover-up and I believe both detective superintendent Garnet and deputy assistant commissioner Connors are guilty of perverting the course of justice, assisting known offenders and, of misconduct in public office. A letter of appeal thirty pages long was sent to assistant commissioner Connors by the four original informants of which I was one. Despite the significant content in the appeal letter superintendent Garnet

maintained no crimes were committed, the matter is now closed and no further time will be allocated to crime number 6029679/21.

What I found most disturbing about this alleged investigation is that not one of the four hundred witnesses, whistleblowers or experts who provided signed evidential statements to the metropolitan police were ever contacted or spoken to by any detective or officer from within the metropolitan police. This in itself is a clear breach of all criminal investigation rules and procedures.

In late March 2022 I made a complaint to the metropolitan police against deputy assistant commissioner Connors and detective superintendent Garnet of misconduct in public office, perverting the course of justice and assisting known offenders. Sergeant Norton at Charing Cross police station took the complaint on the 30th of March 2022 and I was issued with CAD reference number 1879 of 30/03/2022.

Sergeant Norton stated the complaint is so serious and because it is against management within the Metropolitan police, he will have to send this complaint onto the most senior directorate for them to deal and somebody would be in contact to obtain more details at a later date.

Despite me making multiple requests for updates I have never been contacted by any police officer or civilian within the Metropolitan police about this complaint and I have no idea if either officer were ever interviewed or even spoken to.

While all of this is going on and as the days, weeks and months go by, more and more evidence is coming to light of the harm, injury and death being caused by the COVID-19 vaccines. It is still being willfully and deliberately ignored by the government, the civil service, the National Health Service and many times by the police. The media were also refusing to raise any awareness surrounding these extremely serious and evidenced concerns.

As a result of this willful ignorance by the state to stop the harms, many large protests were taking place across the United Kingdom, outside vaccination centres and letters were being written to schools, doctors, pharmacies and members of parliament. Letters and emails were also sent to senior police demanding the vaccines are withdrawn in order to protect the British public from any further harm, injury and death.

The general consensus and documented replies I received personally and I also saw replies sent to many others were:

“We are following the government guidelines.”

It was clear and obvious no matter what evidence was provided to any government department, to the police or the regulators, they were not going to investigate government ministers, or investigate COVID-19 and will not put a stop to the ‘vaccination’ program.

The government ministers were telling me and many others to contact the police if we allege criminality. When we contacted the police they would advise me and others to contact the government ministers because it was a matter for them not the police. Over a twelve month period I sent seven emails to Baroness Hallett chair of the covid inquiry. They acknowledged every email but stated if I am alleging crimes are being committed to contact the police.

The only way to stop the harm, injury and death was for the public to take matters into their own hands in order to protect their families, friends, neighbours and colleagues.

Across the U.K a number of people attended vaccination centres to warn the unsuspecting public about the dangers of the vaccines. This action was in the form of handing out leaflets, talking to those going into the vaccine centres and interactions with the staff within the centres themselves.

On the 1st of October 2022 I attended the University of West England (UWE) in Bristol. I was with a number of others, and Mr Dale Vincent was present also. The reason for attending this Centre was because we had reason to believe many thousands of people would be receiving the vaccines - including children. It was now our public duty to try and alert the people and the staff of the dangers of these vaccines, and plead with them to stop taking them and for the staff to stop giving them.

I had in my possession a substantial amount of documented evidence that came from not only our own government, but from data experts, ONS, doctors and world-renowned clinicians that evidenced and proved the harm, injury and death being caused by the Covid 19 'vaccines' is catastrophic, and being willfully ignored by the authorities.

I was polite, courteous, smartly dressed and remained calm and respectful as did all those attending with me. The staff at the centre called the police. The Police attended and the officer in Charge was Inspector 4603 Lypiatt from Avon and Somerset Police.

Inspector Lypiatt engaged with us and for about 1 hour I went about showing him the evidence I had in my possession detailing the harm and death the vaccines were causing. Of particular importance was the recently released peer-reviewed paper by world renowned London-based cardiologist Dr Aseem Malhotra.

In this peer reviewed paper, Dr Malhotra identified serious concerns about the amount of vaccine recipients injured or harmed and the very high number of vaccines that need to be administered just to prevent one Covid hospitalisation or death. From his nine-month research it shows and proves the supposed cure is far worse than the disease.

Inspector Lypiatt saw enough evidence that was provided to him on the day, I think he Closed the NHS Centre down, and the NHS to review this evidence. He also issued us with a Crime Number - 5222236390.

The centre was then closed on police and NHS advice and we were told somebody would be in contact to let us know what was going to happen moving forward as a result of our attendance.

To my total shock and horror, I found out that the centre had reopened on Monday the 3rd of October and they were administering the vaccines, this despite promises they would make contact to let us know what was going to happen.

On Tuesday, the 4th of October I re-attended the UWE in Bristol with a number of other people and Mr Dale Vincent was also present. When I arrived at the centre, there were three large males who were private security guards at the entrance to the vaccination hub.

Two uniformed police officers were also in attendance; Pc 693 Simon Topps and Pc 4692 Dexter. I asked them if there was an incident number created as a result of our attendance and they confirmed there was and told me it is Log number 203 of the 4/10/2022.

I engaged extensively with both officers. They were aware I was a retired police constable and I made it clear to them crimes were taking place on the premises and I went through a timeline of events that led up to us being at the centre. Other people who were present engaged with the officers and the security guards. Mr Dale Vincent was also speaking to both officers.

It was becoming blatantly clear that no matter what we said neither officer were going to stop the vaccines from being given. What was most upsetting and something we found very difficult to deal with was the number of children we could see in the queue going in to get these very dangerous so-called vaccines.

I had in my possession the peer reviewed paper from Dr Aseem Malhotra. I also had Dr Malhotra's telephone number, Dr Malhotra said he would talk to the police and the NHS manger at the site on the phone, and he would explain why the vaccines must be stopped.

Many times I requested for both officers to speak to Dr Malhotra and they point blank refused. I explained he is one of the worlds leading cardiologists and what he has found is a huge concern, but the officers would not speak to him.

Inspector 424 Barker then arrived at the university. Inspector Barker refused to acknowledge or engage in conversation surrounding the crimes that we knew were being committed. He basically told us we need to leave. I advised him that he has a duty to protect the public from harm, injury and death. I also asked him to speak directly with Dr Aseem Malhotra and he too refused.

Inspector Barker walked away from me. I followed him and made it clear that he is misconducting himself in public office, which is a criminal offence, and he too could be arrested. He ignored my protestations and locked himself in a police van that was parked nearby with two of his colleagues on board.

I was so shocked at this Inspector's appalling conduct, lack of courtesy, professionalism and cowardice that he had to hide and lock himself in the van and ignore the evidence. He point blank refused to speak to Dr Aseem Malhotra and allowed the vaccinations to continue.

When I walked back to the front of the centre I could see Dale Vincent stood in front of the police car and he was refusing to allow the two officers to leave. He was demanding they do their job; stop the harm, injury and death from being caused, and he was not going to move until they carried out their lawful public duty.

Further conversations took place between the three of them. Both officers still refused to do their job and Dale Vincent made it clear to them, their behaviour constitutes misconduct in

public office and they will be arrested under section 24a of the Police and Criminal Evidence Act 1984 if they do not perform their duties.

Then to my absolute horror I saw both constables get out of the police vehicle, pick up their large personal rucksacks from the back seat, lock the vehicle and started to walk away from the centre leaving the police vehicle in situ.

As a group we followed both officers, and I was explaining to both of them that they are leaving the scene of a crime, and they are liable to arrest for misconduct in public office. Dale Vincent and others also told them what they were doing was wrong, unlawful and they will be arrested for Misconduct in Public Office.

Both officers just kept walking away and totally ignored requests for them to do their job. There was more verbal interaction, but it was falling on deaf ears, and at some point, while walking, I saw Dale Vincent approach Pc Topps and he said something similar to;

“If you don’t stop I’m going to arrest you for misconduct in public office”

Both officers continued to walk away and at this point Dale Vincent stood in front of Pc Topps and said that’s it;

“You are under arrest sir for misconduct in public office, stay where you are.”

At no point did Dale Vincent touch Pc Topps. Dale Vincent stood in his way with his hands up, he moved from left to right trying to stop the officer from going any further and no hands were laid on the officer.

Dale Vincent continued to tell the officer to stop walking away, that he was under arrest. It was at this point Pc Topps used his police radio and asked for assistance and said that he’d been assaulted. This in my opinion, having witnessed the whole incident from start to finish was a blatant and fabricated lie.

We all stood as a group, both officers didn’t move any further and we stayed and waited for about five minutes until a number of other officers turned up including Inspector Barker.

We tried to explain to the officers and Inspector Barker, yet again none of them were prepared to listen. They didn’t accept anything that we were saying and as far as they were concerned, we were on private property and we needed to leave.

After a few minutes the owner of the property came out and he handed me a letter, the letter stated we all need to leave the site, it is private property and Inspector Barker also confirmed if we did not leave we will all be arrested for aggravated trespass.

It was at this point, I became aware Dale Vincent had been arrested on suspicion of assaulting Pc Topps we protested to the constables because no assault took place and we had the whole interaction on video. We were blatantly ignored and they took Dale Vincent away in handcuffs in the police van and we then left the site.

Some months later I learned from Dale Vincent he was charged with assault on an emergency worker and I could not believe this - considering the amount of video evidence that any charges would ever be brought. It is my opinion having been there from start to finish, and knowing the law as a retired police constable, Dale Vincent did not commit any criminal offence, he did not assault Pc Topps, and he should never have been arrested. I still do not know why after his arrest he was placed in handcuffs, there was no justification at all for restraining him.

Dale Vincent was polite, compliant, not in possession of any weapons, was not threatening or using violence, he was not at risk of escape, he was not hiding or trying to destroy any evidence of crime, he was no danger to himself, any officer, or a member of the public, he also made it very clear he would comply and he went willingly with the arresting team.

The police, ministers, civil service and regulators forced the public to take matters into their own hands. The obvious, blatant and willful refusal by any official to stop or even pause the Covid 19 vaccines is a crime in itself. The overwhelming evidence is ignored and the vaccines lauded as a great success and deemed as the Holy Grail and can never be questioned, this is a travesty. This couldn't be further from the truth.

The police are publicly paid servants, they are supposed to be independent and act without fear or favour, upholding and enforcing the rule of law when necessary. Yet, we are witnessing the police for the government, and no longer working for the people, by the people of the people. It is clear from my multiple dealings with police of all rank in many forces especially the Metropolitan police, named and known offenders in public office are being protected by the police.

There is only one law and no man or woman, no matter title or financial status, no corporation public or private, are above the law. We are all equal in the eyes of the law and equality before the law is paramount. It is abundantly clear the police have forgotten this or even worse they are being ordered to ignore their impartiality, and in doing so dishonour and disrespect their oath or affirmation of office.

Where the British police have willfully and deliberately failed, the British people are duty-bound to act. The law allows us to protect each other from harm, injury, loss or damage to our property and we can arrest anyone guilty of these crimes. Dale Vincent exercised his right in law and arrested Pc Topps using section 24a of the Police And Criminal Evidence Act of 1984; also known as a citizens arrest.

Also in law anyone can use force as is reasonable, necessary and proportionate as outlined in section 3 of the criminal law act of 1967. Dale Vincent did not use any force. He never laid hands on Pc Topps. However in law he could have detained Pc Topps to prevent him from walking away while under arrest.

Dale Vincent acted within the confines of the law of the land for which he is entitled to do under the given circumstances already outlined.

There is nothing written in law or in the Police And Criminal Evidence Act 1984 that states, police constables in or out of uniform cannot be arrested if they are committing a crime or are guilty of committing a crime. They are not above the law.

There is nothing written in law or in section 24a of the Police And Criminal Evidence Act of 1984, or section 3 of the Criminal Law Act of 1967 that states, police constables in or out of uniform cannot be arrested if they are committing a crime, or *you believe* they are guilty of committing a crime.

Therefore the arrest of Pc Topps by Dale Vincent was lawful and justifiable.

I am making this statement on the 9th of December 2024, more and more evidence has been made public about the harms the Covid 19 vaccines continue to cause.

This further evidence is still being sent to the authorities and the police. It is still being willfully and deliberately ignored. As a consequence we are seeing a massive increase in excess deaths since the rollout of the 'vaccines'; including turbo aggressive cancers, heart attacks and strokes are at an all-time high. It is the COVID-19 vaccines that are responsible for this.

It is the duty of all public officials to honour the fact they are paid with public money, they should and must do everything they can to protect the public from harm, injury and death. The most concerning evidence that has come out in the last few months is the publicly available contracts between Pfizer and world governments for the purchase of the Covid 19 vaccines.

I am in possession of five of the original contracts between Pfizer, the South African government, the Canadian government, the Brazilian government, the European Commission and Albania government.

In all five contracts Pfizer clearly documents and details to every government - when they purchase the COVID-19 vaccines they, acknowledge that Pfizer do not know the long-term effects or efficacy of the vaccines.

This begs the question - where did safe and effective come from, and more to the point how did they arrive at 95% effective when Pfizer themselves are telling us in the contracts they don't know?

These five different contracts were signed by government representatives and Pfizer representatives between late November 2020 and early April 2021.

So with this in mind, we have to assume the UK government signed the same contract because they started to administer the COVID-19 vaccines on the 8th of December 2020.

The UK government knew the vaccines were not safe and effective, and the UK government knew they were not 95% effective. More worryingly and concerning is the fact the lawyers acting on behalf of the people working for the government also knew this and they still allowed these contracts to be signed.

I provided these contracts to the police and a government minister and to the chief constable of Thames Valley police Jason Hogg and still no action has been taken to stop the vaccines and arrest the offenders.

The UK government, its ministers, civil service and the solicitors representing the people have willfully, deliberately and knowingly put the British public in harms way and allowed them to be used as guinea pigs for a new untested, unsafe and novel mRNA injection.

The COVID-19 vaccines are dangerous and causing devastation across our nation and around the world. They are a bio weapon and must be withdrawn. All vials must be seized by the police as evidence of serious crime and the fact they have not done this and continue to refuse to do this to me shows that Dale Vincent acted with honour and integrity. His only intention was to protect the men, women and children of this country in the absence of a functioning police force, government and civil service.

It is only right and proper this matter goes to trial. A jury of our peers, 12 good men and women who can hear and see for themselves the harrowing evidence and the catalogue of blatant failures of government, the civil service and the police. I have no doubt they will see Dale Vincent for what he is, a hero of the people. This man fought many times for his country overseas in the military and he's never forgotten his sworn duty, not just to protect the people around the world, but the men, women and children in the United Kingdom.

I make the statement of my own volition, I make it knowing and believing its content is accurate and true to the best of my knowledge and everything I have asserted to is fully documented and I have proof of the same.

I maintain and assert the COVID-19 pandemic was fake and I make this assertion because while everybody was locked down in their homes, the prime minister and many other government ministers and civil servants were partying in Downing Street and other government locations. They clearly didn't fear a deadly virus and none of them were social distancing or wearing masks.

This considering Boris Johnson in April 2020 was supposedly in hospital on death's door from contracting COVID-19. Yet some eight months later he is partying long and hard with his friends and colleagues in Downing Street. He admitted his many crimes and he received a £50 fine. This makes a mockery of Justice and the law and proves they weren't scared of any virus.

All of the rule makers were breaking the rules and not one of them died or were hospitalised considering their many blatant breaches of their own rules.

For anyone who dared challenge the COVID-19 pandemic or the vaccines they were called anti-vaxxers, tinfoil hat wearing lunatics, and discredited in the media and on social media. Why?

Surely in a democratic society - why has there never been an open and transparent debate? It has been asked for many times by eminent experts. The reason is because the truth will come out and it will destabilise the British government, the civil service and discredit the British police who are fully aware of all of these crimes and those guilty of committing them.

Very recently the British public have been made aware of the Post Office and the tainted blood scandals. From these enquiries it was made clear the government knew about the Post

This also came out in the tainted blood scandal where the government knew for fifty years about the harms the tainted bloods were causing, the catastrophic effect it had on the families and the premature deaths of many thousands of people. These ministers and civil servants committed serious crimes but are never held to account. Why?

Are we prepared to wait another thirty, forty or fifty years to realise the harm, injury and death the COVID-19 vaccines are causing? Or are we going to do the right thing this time and stop them being given?

Many hundreds of thousands, if not millions of vaccine injured, need urgent medical help. We must arrest those responsible and hold them accountable for their crimes but most importantly, remedy and redress for the many millions of victims across the nation.

I have seen a significant amount of evidence from the independent experts around the world, those I have spoken to personally, the many meetings I've organised and been involved in, not just in Westminster but Parliament and all around the country. I met with some of the greatest minds in the medical field, forensic scientists, geneticists, data experts, lawyers barristers, funeral directors, MPs and independent journalists and it's clear the COVID-19 vaccines must be stopped immediately in order to prevent any further unnecessary harm, injury, suffering and death.

This statement is in no way frivolous or vexatious. It is made on the understanding that it will be used in a court of law and read out to a jury of my peers. I am prepared to attend court and give my evidence under oath.
